7. Revised Constitution and Procedures

A revised KCi Constitution and accompanying Procedures, previously approved in Committee, had been distributed and available on KCi website for the public to view. The revision was to meet the intentions of the revitalised KCi committee as well as the requirements of the new Incorporated Societies Act 2022. The revision is subject to review by the Charities Services NZ.

8. General Business

i. KCi Annual Membership Fees

There was a discussion on the two types of membership proposed in the new constitution – Citizen and Business, and Community Groups.

David moved that Business membership be \$55 + GST and that Citizen membership be \$5

There was a discussion on the benefits of membership, which include:

- a proposed 10% discount for one advertisement per year in Kamo Connect
- a business listing on KCi website
- membership list on back page of Kamo Connect
- All the improvements to Kamo achieved by KCi

Ruth moved to amend the proposal to \$35 for Business and \$5 for Citizen.

Seconded Darryl Davies Carried

Ruth proposed that advertising in Kamo Connect to be decided in Committee with discussion with The Publishers. Agreed.

There was further discussion on membership, and a question from the floor by Johnathan Jarman as to why the fees for the two types of membership were different. After some discussion it was decided that they didn't need to be, and business membership did not need to be linked to advertising in Kamo Connect. The idea is to increase membership. It is not about revenue generation or publication of Kamo Connect. It was agreed \$10 is an affordable sum for membership by everyone. Also agreed there needs to be an article in the September issue of Kamo Connect to inform the community of these changes.

John Nuttall moved to rescind all previous motions on membership Seconded by Marie Olsen Carried

Marie Olsen moved that the annual membership of KCi be set at \$10.00 incl GST for everyone, although the two types of membership be retained.
